Ground rent charges as per applicable tariff for empty container plus Rs.1200/- per TEU per day.

**INSURANCE CHARGES:** On Containerized Cargo Rs.12.5 paise per 1000 rupees per week or part thereof

- No insurance charges is payable if a valid policy is produced before entry of container into CFS or at the time of entry inside CFS campus.
