FINAL ORDER

The matter is taken up today for final disposal. It is the case of Kolkata Port Trust (KoPT), applicant herein, that M/s East India Watch Co., O.P. herein. came into occupation of the public premises in question being Pucca Room no. 1 measuring about 5.016 sq.mtr. or thereabout situated at West side of Strand Road, Thana-North Port Police Station, Calcutta, under Plate no. SW-102, on a monthly lease basis on certain terms and conditions and O.P. violated such conditions by way of default in making payment of the rent and taxes. O.P. was issued a quit notice on 19.05.2006 asking to hand over the vacant possession of land on 01.07.2006. It is the claim of KoPT that O.P. is liable compensation/damages to KoPT for unauthorized occupation of the premises 01.07.2006. During course of hearing, it was application dated by KoPT (vide submitted 16.03.2017) that the entire premises had been gutted in a fire on 14.02.2010 and as such, the possession of the premises was thereafter with KoPT. On 07.11.2017 this forum issued show cause notice of the Public Premises (Eviction of Unauthorised Occupants) Act 1971 for adjudication of the prayer of recovery of damages, interest etc.

It is seen from the record that no one appeared on behalf of O.P., during the course of hearing before this forum. It appears that the notice sent through registered post at the recorded address of O.P. was returned by postal department with the endorsement "insufficient address". As per order of this forum,

notice of the Proceeding was published in an English daily namely "The Telegraph" dated 02.01.2018 for notice to all concerned, to appear before this forum either person or through authorised representative capable of answering all material questions in respect of the property in dispute. But still no one appeared on behalf of O.P. in spite of paper publication. Thus being satisfied with the service of notice/s to all concerned as mandated under law, this forum, after hearing the argument of KoPT proceeded to reserve the final order on 23.03.2018.

I have carefully gone through the contention made by KoPT against the O.P. and the supporting documents submitted in this respect. On perusal of submissions and materials available on the record, I have nothing to disbelieve the claim of KoPT. KoPT has placed on record computerised statement of accounts, maintained in official course of business, and I find the same very much reliable, in the facts and circumstances of the case.

In view of the circumstances, as O.P. failed to appear before this forum and no reply to show cause notice u/s 7 of the Act is filed by O.P., I am left with no other alternative but to issue the order against O.P. to pay the damages and accrued interest thereupon as contended by KoPT before this Forum.

It is my considered view that a sum of Rs. 30,134.00/- for the period from 01.07.2006 up to 14.02.2010 (both day inclusive) is due and

recoverable from O.P. by the Port authority on account of damages and O.P. must have to pay the said compensation/damages to KoPT on or before 15.10.2018. Such damages/compensation attracts interest @ 18% per annum 06.04.2011 thereafter @14.25% per annum on the above sum from the date of incurrence of liability till its final payment in accordance with notifications published in Official Gazette.

ACCORDINGLY, I sign the formal order u/s 7 of the Act as per Rule made there under, giving time till 15.10.2018 to the O.P. to pay the damages and accrued interest thereupon.

I made it clear that in the event of failure on the part of O.P. to pay the amounts to KoPT as aforesaid, Port Authority is entitled to proceed further for recovery of its claim in accordance with law. All concerned are directed to act accordingly.
