Sub: Vaccination for COVID-19

This is to inform you that Secretary, Department of Health and Family Welfare, Govt. of India, vide letter dated 3.4.2021 (copy enclosed for ready reference), has, inter alia, informed that no fresh registration in categories of Health Care Workers (HCWs) and Front Line Workers (FLWs) would be allowed with immediate effect. However, universal vaccination of already registered HCWs and FLWs would be ensured at the earliest.

- 2. In view of this, it has been decided that the following personnel would be eligible to be vaccinated at Centenary Hospital, henceforth:-
- i) All employees of SMP, Kolkata (both of KDS and HDC), who are 45 years of age or more:
- ii) Any family member of SMPK employee, who is 45 years of age or more;
- iii) All retired employees of SMP, Kolkata and their spouses who are 45 years of age or more;
- iv) All direct contractual employees of SMP, Kolkata, who are 45 years of age or more;
- v) All employees of contractors engaged by SMP, Kolkata, who are 45 years of age or more;
- vi) Anyone who is 45 years of age or more, even if he/she is not a beneficiary of SMP, Kolkata;
- vii) Any employee/direct contractual employee of SMP, Kolkata and any employee of contractors engaged by SMP, Kolkata, who (irrespective of age) have already been administered the first dose of vaccination, would be eligible to receive the second dose of vaccination.
- 3. Accordingly, you are requested kindly to advise the aforesaid persons to approach Centenary Hospital along with original Aadhar Card, for vaccination.
- 4. This issues in supersession to this office letter of even No. dated 18.03.2021.
