DECLARATION U/S 206AB AND 206CCA OF THE INCOME TAX ACT,1961.

As per section 206AB and 206CCA of the Income Tax Act, 1961 effective from 01/07/2021, if any party has not filed its return of income in the last 2 preceding years in which the last date of filing return of income under section 139 has expired, he will be liable to deduction of tax/collection of tax at a higher rate. However, this section will be applicable for assessees in whose case the aggregate of tax deducted at source in each of the 2 previous years is Rs 50,000 or more. Hence, all parties are required to submit the declaration attached along with copies of acknowledgement of filing of income tax returns of preceding 2 years immediately. If no declaration is received from the party, it will be assumed that the party has not filed return of income in the last 2 preceding financial years and its aggregate TDS /TCS in the last 2 years exceeds Rs 50,000 and thus TDS/TCS will be made at higher rate.
