**Subject: Life Certificates of pensioners and family pensioners of
KDS, SMPK (erstwhile KoPT)**


As you are aware, the Pension Disbursing Bank collect Life Certificates from the pensioners of SMPK (erstwhile Kolkata Port Trust) in the month of November every year and intimate the Pension section of SMPK about life certificates received by them. As already advised, pension payment may be stopped immediately from January of the following year, if Life Certificate is not furnished by the pensioner or family pensioner within 30.11.2021.

In this connection it may kindly be noted that Competent Authority of SMPK (erstwhile KoPT) has decided to continue pension to the pensioners till October 2022 for those who have submitted their Life Certificates on and from 01.09.2021 to 30.11.2021 and onwards either in hard copy or through Jeevan Pramaan Portal under Syama Prasad Mookerjee Port, Kolkata. This office will provide a list of DLC (Digital Life Certificate) received through Jeevan Pramaan Portal by this office to your bank on 1st week of December'21 for continuation of their pension without any interruption.

Pensioners of SMPK registering their Life Certificate through Jeevan Pramaan Portal under Syama Prasad Mookerjee Port and this office had already intimated to your bank vide this office letter No. Fin/PSLI/20/747 dated 17.11.2020 to accept hard copy of DLC, if furnished by the pensioners/family pensioners to your bank. You are also advised to encourage the pensioners to go for Digital Life Certificate for better pension management through Digital Mode.

It is requested that for the current year 2021-22, a copy of Life Certificate collected from the pensioners / family pensioners from September'21 to November'21 (i.e. 01.09.21 to 30.11.2021) should be forwarded to this office by 15th December'21 (with a consolidated statement in an excel format) and also the pension payment must be stopped from January 2022, if Life Certificate is not furnished by any pensioner /family pensioner within 30.11.2021.
