TRADE NOTICE

This has reference to Notice No. Mrn/71/58 dated 29th April, 2016 and Notice dated 29th July, 2016 (Copies attached). Following is clarified:-

- For hazardous cargo under Category-I [Flash Point below (+) 23°C], the Importer / Exporter / Container Agent and Vessel Agent has to execute Indemnity Bond as per the prevailing format of SMPK whenever the quantity exceeds 20 MT.
- 2. For hazardous cargo under Category-II [Flash Point below (+) 23°C to (+) 65°C], the Importer / Exporter / Container Agent and Vessel Agent has to execute Indemnity Bond as per the prevailing format of SMPK whenever the quantity exceeds 150 MT.

Other conditions as stipulated in the above-stated Circular remain unchanged.

NOTICE

The limits of handling Hazardous cargo in Kolkata Port have been revised as follows:-

- 1. Category I [Flash Point less than (+) 23°C] ------500 MT
- 2. Category II [Flash Point (+) 23°C to (+) 65°C]------2000MT

Subject to the following conditions:-

- a) Only one container to be handled at the quay side at a time both for import/export.
- b) The container after unloading should be removed directly out of the dock or to the CFS having appropriate facilities to store such cargo. The Container/Vessel Agent shall be responsible for removal of the containers from the Port & storage at any off-dock CFS having appropriate facility.
- c) Both the importer/exporter and the agent of the vessel shall submit a bond to indemnify KoPT against any of its losses and also against all third party liabilities arising out of the said operation.
- d) The party should comply with the stipulated safety measures.
- e) The importer/exporter must comply with the order of the West Bengal Pollution Control Board dated 25.02.2016.

"Competent authority has revised the limits of Category-I Hazardous cargo[Flash Point less than (+) 23°C] to 500 MT and Category-II Hazardous cargo [Flash Point (+) 23°C to (+) 65.5°C] to 2000 MT subject to following conditions:

- a) Only one container to be handled at the quay side at a time i.e. the second container should be unloaded only after the first container has been removed from quay side.
- b) The container after unloading should be removed directly out of the dock or to the CFS having appropriate facilities to store such cargo. The Container/Vessel Agent shall be responsible for removal of the containers from the Port & storage at any off-dock CFS having appropriate facility.
- c) Both the importer and the agent of the vessel shall submit a bond to indemnify KoPT against any of its losses and also against all third party liabilities arising out of the said operation.
- d) The party should comply with the stipulated safety measures.
- e) The importer must comply with the order of the West Bengal Pollution Control Board dated 25.02.2016"
