Subject: Extension of additional medical benefits to the members of existing "CPT Retired Employees (Contributory Outdoor and Indoor Medical Benefits)
Scheme,1997" on the occasion of Sesquicentenary Celebration of KoPT –
Cancer Treatment

This has reference to this office earlier circular bearing No. Admn/3851/13/1/A dated 11.05.2020.

- 2. The issues relating to Cancer treatment have been examined in detail and accordingly, the following have since been approved by Chairman:
- (i) Investigations specified in the aforementioned circular dated 11.05.2020 (for patients not suffering from cancer), will be referred to one of the tie up Centres, for availing of CGHS rate benefits, with a computerised referral slip mentioning cash payment with future reimbursement option.
- (ii) The listed treatment will also be referred to the tie up Centres (for patients not suffering from cancer), for availing of CGHS rate benefits, with a computerised referral slip mentioning cash payment with future reimbursement option.
- (iii) Computer generated referral slip will not be needed for Cancer patients who are referred to outside tie up Centres either for investigations or for treatment.
- (iv) In all the above circumstances, patients will be required to submit their bills for reimbursement separately for investigation and treatment.
- (v) However, the cost incurred by SMPK for treatment of cancer patients at the Centenary Hospital, KDS/Port Hospital, HDC, will not come under the purview of the fixed ceiling communicated by the aforementioned circular dated 11.05.2020, subject to the condition that the patient would not claim reimbursement for taking treatment in other Centres for the same ailment.
- (vi) Thus, the medicine available and provided by Centenary Hospital, KDS or Port Hospital, HDC will not be deducted from the monetary limit, only if the patient receives treatment in any one of these hospitals. However, this facility will cease to exist after the hospital is handed over to the Concessionaire.
- 3. You are requested to take necessary action accordingly.
