The warranty of 12 months will be applicable from date of satisfactory acceptance of materials to KoPT (Hydraulic Study Department).

100% payment will be made after delivery of materials, satisfactory acceptance of the same and submission of Bank Guarantee of 10% of the total order as mentioned in your offer on any scheduled bank at Kolkata. In case of outstation bank, the same should be duly endorsed by branch located at


Kolkata so that claim can be lodged at that Kolkata Branch. Bank guarantee format is available in GCC of KoPT. If such Bank Guarantee is not provided, payment @ 90 % of the total cost will be made. Payment of balance 10 % will be made after satisfactory completion of warranty period (Manufacturer's Standard maintenance plan) of 1(one) year from the date of acceptance of the license (dongle) by KoPT.

Bills in quadruplicate for the supply are to be submitted to the office of the Chief Hydraulic Engineer along with certificate of satisfactory acceptance of materials from Hydraulic Study Department, KoPT.

The GCC of KoPT will be applicable for the instant work order. The GCC of KoPT may be downloaded from our website.

An agreement on Non Judicial Stamp Paper Rs.100/- is to be executed regarding execution of the instant work order.

This may be treated as formal work order and it is requested to return one copy of the same duly signed and stamped as a mark of acceptance.
