In the event of refusal or failure to comply with this order Shri Gora Chand & Ors., Quarters being No. 7 & 8, Block No. K, at Taratala New Colony Mazdoor Line, P.S. Taratala, Kolkata – 700 088 and all other persons concerned are liable to be evicted from the said premises, if need be, by the use of such force as may be necessary.

FINAL ORDER

It transpires from record that several opportunity was granted to O.P. to surrender the subject quarter to the authorized representative of KoPT, but O.P. failed to honour his commitment to surrender the subject quarter to the officials of KoPT. As such, I have nothing to disbelieve the statement made against O.P. by the Port Authority. In fact, I am left with no other alternative but to issue order of eviction as prayed for on behalf of the Port Authority on the following grounds/reasons.

- 1. That you have failed to file reply to the Show Cause Notice u/s 4 of the Act inspite of repeated chances.
- 2. That nothing has been shown in support of O.P's occupation into the public premises.
- 3. That no evidence has been laid to support the possession of O.P. as "authorized possession/occupation".
- 4. That mere occupation into the quarters for a certain period without any authority for such occupation cannot create any right over the property in question.
- 5. That O.P has failed to hand over clear vacant and unencumbered possession of the subject quarter

ACCORDINGLY, Department is directed to draw up formal order of eviction u/s. 5 of the Act and Rules made thereunder against O.P., giving 15 days time to all to vacate the public premises. I make it clear that all the occupants of the
