



Record is put up today on the basis of application 09.08.2019 dated No.Lnd.5468/19/1709 bearing received by this Forum on 13.08.2019 filed by KoPT. It transpires from such application dated 09.08.2019 of KoPT that O.P. came into occupation of the Port Property being land measuring about 195 sq.mtrs. situated at "A" shed Jagannath Ghat Warehouse in the presidency town of Kolkata (under Plate No AJ-4) as a Licensee for 11 months term i.e upto 30.04.2018 and thereafter O.P's occupation was unauthorised from 01.05.2018. It is submitted that O.P. has no authority under law to occupy the public premises after issuance of vacation Notice dated 17.06.2019 and was required to hand over the possession of the property in question to KoPT as required under the vacation Notice. My attention is drawn that the cause of action arises upon failure on the part of the O.P. to hand over possession in terms of the said notice dated 17.06.2019 as duly served upon O.P and this is well-within the jurisdiction of the Office of the Estate Officer. It is also submitted that abovementioned property was severely damaged by fire on 08.06.2019. KoPT in its original application has submitted that the fire-damaged structure was inspected both by its inhouse structural engineering team and that of Kolkata Municipal Corporation. Both suggested immediate demolition of the structure given the present precarious state of the building as its present condition is dangerous to life and property. The Kolkata Municipal Corporation has already issued notices to KoPT on 11.06.2019 and 11.07.2019 directing immediate demolition and removal of debris of the first floor and demolition of dangerous portion at ground floor.

It is argued that O.P. is in wrongful occupation on and from 01.05.2018 and is liable to pay compensation charges/mesne profits for unauthorised use and occupation of the Port property in question. It is also seen from report of experts that the present condition of the subject premises/building after the damage caused by fire on 08.06.2019, is deplorable and unsafe and it is posing serious threat to life and may collapse at any time owing to which Kolkata Municipal Corporation has already issued notices to Kolkata Port Trust on 11.06.2019 and 11.07.2019 for immediate demolition of

portions of Ground Floor of the building.

Let notice under Section 4 of the Act be issued to O.P. for production of documents, evidence and hearing etc. on 15-10-19 at 11 hm.

The notice must have to be served upon O.P. through Registered Post with A/D, affixation on property etc. O.P. and/or any party interested in the subject property to file reply to show cause notice by 15-10-19.

[So far as Section 7 is concerned, it will be issued at later stage after submission of consolidated Statement of Accounts by KoPT.]

Parties are directed to appear before the Forum of Estate Officer with proper identity and authority.

All concerned are directed to act accordingly.
