**I. NOTABLE ACHIEVEMENTS / DEVELOPMENTS**

**Chairman, Paradip Port takes over the additional charge of Chairman, SMPA**


**Chairman, SMPK inaugurates the Operation of Unmanned Survey Vessel on his maiden visit to HDC**

Built eight decades ago, P.S. Bhopal, a paddle steamer resumed its journey on 1.10.2022 after resurrection as a Heritage Cruise Vessel cum Museum with thorough repair, renovation and restoration. On the occasion Shri Vinit Kumar, the erstwhile Chairman remarked, "We have restored the heritage value and made the vessel commercially viable also, which is a very rare combination."

## Special Campaign 2.0 observed at SMPA, Kolkata

As a part of Special Campaign 2.0, the initiatives taken by SMPA are:

- Beach cleaning activities carried out on 19.10.2022 at Haldia Dock Complex of SMPA, Kolkata. Employees of HDC and the CISF personnel participated. About 450 kg plastic debris was cleared from the area. Cleaning activity was carried out alongside river front at HDC, SMPA wherein HDC employees, CISF personnel participated. About 550 kgs. plastic/ debris could be cleared from the area. Indoor cleaning was carried out on 14.10.2022 & 15.10.2022.
- An Awareness Programme on E-Waste Disposal was held at HDC of SMPA, Kolkata on 26.10.2022. About 25 officers & employees participated. Dy Chairman, HDC encouraged everybody present to spread awareness on the issue throughout the organization as well as in the society at large.
- Under the guidance of MoPS&W and as a part of Special Campaign 2.0, the disposal of the Ballast Water Treatment Plant (about 600 MT) was completed on 14th October, 2022 with scrap value amounting to Rs. 2.41 crores.
- On 22.10.2022 cleanliness drive was undertaken by the Marine Department, KDS being initiated at the Upper Reaches Survey Station (URSS), Budge Budge on 23.10.2022.
- De-weeding of water hyacinth in the KPD water body at the turning basin of SMPA, Kolkata was also carried out by Marine Department, SMPK.
- On 28.10.2022, Dy Chairman (K) led a team of officials from GAD & Finance Departments in the cleanliness drive at the Sovabazar Ghat.

Indian Oil Corporation exported 1.9 TMT for the second time through this route. This improves supply and cost efficiency of energy trade with Bangladesh.</p>

## **II CARGO THROUGHPUT :**

- SMP, Kolkata handled 36.089 million tonnes (mt) of cargo during April 2022-October 2022, vis-à-vis 31.982 mt during Apr'21-Oct'21, registering an increase of 12.84% and ranked 5th position in Cargo handling amongst Indian Major Ports.
- HDC handled 26.864 mt of cargo during Apr'22- Oct'22 vis-à-vis 23.521 mt during Apr'21- Oct'21 (an increase of 14.21%). KDS handled 9.225 mt of cargo in Apr'22- Oct'22 vis-à-vis 8.461 mt during Apr'21- Oct'21 (growth of 9.03%).
- HDC registered growth in respect of POL (Crude), LPG, Manganese Ore, Other Ore, Fly ash, Lime Stone, Coking Coal, Non Coking Coal, Petroleum Coke, Metallurgical Coke, Project Cargo, Other Cargo, etc.

while KDS registered growth in respect of Vegetable Oil, Other Liquid, Fertiliser, Iron & Steel, Pulse, Coking Coal, Lime Stone, Container (TEUs), Other Cargo etc. during April-22 to October-22 vis-à-vis similar period of last year.

### ➤ **III CONTAINER TRAFFIC:**

SMP, Kolkata handled 3,95,340 TEUs (KDS:3,34,389 & HDC: 60,951) during Apr'22- Oct'22 vis-à-vis 4,35,807 TEUs (KDS: 3,33,170 & HDC: 1,02,637) during April'21- Oct'21, a decline of 9.29%.

### **IV SHIP TRAFFIC:**

During Apr'22- Oct'22, 1745 ships (KDS: 626, HDC: 1,119) called at SMP, Kolkata vis-a-vis 1697 ships (KDS: 571, HDC: 1126) in Apr'21- Oct'21. 2,242 vessels (1,119 inward; 1,123 outward) passed through Eden Channel during Apr'22- Oct'22 to / from Haldia vis-à-vis 2,258 vessels (1,126 inward; 1,132 outward) during Apr'21- Oct'21.

### **V COMPARATIVE PERFORMANCE :**

SMP, Kolkata ranked 1st in handling of Coking/Other Coal and 2nd in handling of both Other Liquids & Other Misc. Cargo amongst Indian Major Ports during April-October 2022.

### **VI RAILWAY TRAFFIC :**

- During Apr'22- Oct'22, SMP, Kolkata handled rail-borne traffic of 20.523 million tonnes against 16.901 million tonnes in Apr'21- Oct'21, registering a growth of 21.43%. During Apr'22- Oct'22, 876 rakes were received and 901 despatched at KDS; at HDC, 3806 rakes were received and 3810 were despatched during the same period.
- During Apr'22- Oct'22, HDC of SMPA handled Rail borne traffic of 17.067 million tonnes vis-à-vis 13.716 million tonnes handled in corresponding period of previous year, registering a substantial growth of 24.43% . KDS of SMPA too registered a growth of 8.51% by handling Rail borne traffic of 3.456 million tonnes during Apr'22- Oct'22 vis-à-vis 3.185 million tonnes handled during Apr'21- Oct'21.
- During October, 2022, HDC of SMPA recorded highest ever loading of 506 rakes surpassing previous highest record of 475 rakes achieved during September 2022.
- During October, 2022, HDC of SMPA recorded highest ever Coking Coal Loading of 308 rakes surpassing previous highest record of 290 rakes achieved during September 2022.
